**NOTE: The contract renewal option was exercised with limitations. As General Motors is not currently producing Law Enforcement Chevrolet Tahoe vehicles, the supply of same is limited to quantities already on hand. There is not another law enforcement vehicle that falls in this category from any other manufacturer. Love Chevrolet Company will continue to sell the 2014 police model Chevrolet Tahoe as specified at the 2012 contract price of \$25,288. until the supply on the lot has been sold or until October 31, 2014, whichever comes first. If another solicitation is published for this vehicle type before the next bid cycle, the ensuing contract would result in the termination of this contract.**
