Therefore, the following changes to the Addendum are effective upon all signatures:

1. Para 1. Scope

This Addendum covers the WSCA/NASPO PC Contracts 2009-2014 (Computer Equipment, Peripherals and Related Services) lead by the State of Minnesota for use by state agencies and other entities located in the Participating State authorized by that state's statutes to utilize state contracts. **LENOVO (United States) Inc** is authorized under this WSCA agreement to sell the following:

Monitors	(NTE \$50,000.00 each)
ADD: Servers	(NTE \$500,000.00)
ADD: Storage	(NTE \$500,000.00)

2. Para 3 M. Products and Services NOT Provided by this Participating Addendum:

Delete: Servers and Storage

3. Para 6. Servicing Subcontractor:

Delete: "All orders are to be issued directly to: Lenovo..."

Delete: "And all payments are to be issued to: Lenovo..."

Delete, "All orders and payments are to be issued directly to Lenovo (United States) Inc"

ADD: Orders and payments are to be issued to Lenovo (United States) Inc or their authorized Reseller Agent approved by the State of SC. The Reseller Agents approved by the State of SC have been issued separate contract numbers; however all terms and conditions of the MPA and SC PA apply.

All other terms and conditions remain unchanged.
